2015 LTPs - Fit For Purpose?

The answer is a resounding “yes!” Ninety-five percent of the LTP project managers told us their LTP was a success. Almost all respondents asked for no legislative change for 2018.

The project managers told us they most wanted guidance on LTP communications and engagement, aligning the LTP and other plans and asset planning (including the infrastructure strategies). That’s helpful guidance that we’ll take on board in the coming year.

We reviewed and approved a short report *Fit For Purpose?* That sets out the findings from the survey, SOLGM will release this early in the new year.

SOLGM Commences Review of Performance Management Guide

SOLGM will be moving to put the review and development of the LTP guidance back ‘in sync’ with the planning cycle. As a result, and only 157 days after the last LTPs were due, we’ve started the review of LTP guidance with the guide that was left ‘as was’ in 2015.

Currently entitled *Performance Management: Your Side of the Deal*, the first cab off the rank covers strategies, levels of service, measures and targets and performance culture. The Productivity Commission describes the guide as clear and practical, something we want to keep for 2018.

Review of Urban Planning – SOLGM “In the Loop”

The Productivity Commission is conducting what is described as a first principles review of urban planning law in New Zealand. The Government has specifically asked the Commission to consult SOLGM.

Rather than waiting for them to come to us, we've decided to convene a workshop of urban planning experts from within the sector to meet with the Commission and discuss the issues. Three members of PWP, and two other invited representatives will take part.

RMA Reform

The Resource Law Amendment Bill received its first reading on 3 December and has been referred to the Local Government and Environment Committee for submissions. There is no word as yet on the deadline for submissions – we're picking it will be around the end of January.

Finance and Infrastructure Strategies: A Pass Mark

In preparing for the review of this guide ourselves and the Financial Working Party undertook a review of a sample of financial strategies and infrastructure strategies. We reviewed the same report that FWP has and broadly agree with their assessment of its recommendation.
