SOLGM's Planning and Accountability Working Party met on 1 July and covered a variety of topical issues for the sector. In this edition you will find:

National Policy Statement (NPS) - Urban Development

The working party supports the draft submission prepared by LGNZ. There were concerns raised by the working party regarding the implications of the NPS on the sector. We would like to highlight a few issues that may be useful for local authorities considering a submission:

- Provisions within the NPS have relevance to all local authorities
- Cost vs. benefit burden of the NPS needs to be fully considered (particularly on low growth councils)
- Monitoring and information gathering requirements should be considered as a consequence of the NPS

Please note submissions on the NPS close on **15 July.** We encourage all local authorities to consider submitting.

Better Local Services Legislation

The Local Government Act 2002 Amendment Act (aka the Better Local Services Bill) has been referred to the Local Government and Environment Select Committee. The Committee has called for submissions and these will be due on **28 July.**

The Bill essentially gives effect to the Government's Better Local Services reforms – the proposals to provide more flexibility to establish CCOs, transfer functions between councils and the like. This Bill also widens the powers the Minister has to regulate what financial and non-financial performance information is disclosed in our LGA planning and reporting.

We have prepared an exposure draft of our proposed submission to the Local Government Act Amendment Bill (2), aka the Better Local Services Bill. It is provided as the basis for discussion and debate within the local government sector.
